Mansfield Christian School Title I Program School Parent and Family Engagement Plan

- Mansfield Christian School will ensure that information related to the school parent and family engagement

 format, including alternative formats upon request, and to the extent practical, in a language the parents can

 - > Classroom newsletters or emails sent home weekly in easy to understand formats

 - > School notices, as applicable
 - Principal's weekly newsletters
- Mansfield Christian School will work to involve parents in the continued growth and development of the Title I

 - Progress reports and report cards are sent home quarterly
 - > Parents are invited to attend Parent-Teachers Conferences to be updated on the progress of their students
 - > Parents are encouraged to reach out at any time to the classroom teacher or Title I teacher
 - > Parents will be provided individual student reports about their performance on the State assessments
- Mansfield Christian School will provide each parent timely notice when their child has been assigned to or has been taught for four or more consecutive weeks by a teacher who is not highly qualified.
 - All teachers are H.Q.T. (highly qualified teacher) or hold an allowable permit through the Ohio Department of Education
- Mansfield Christian School will aid parents in understanding:
 - > Student academic achievement standards and how those align to school, state and federal expectations
 - State academic content areas and assessments
 - Alternate assessments
 - ➤ How to monitor their student's progress and how to work with teachers
 - ➤ How to effectively work with students at home to support student learning
 - Importance of developing reading and mathematical skills
 - > Importance of reading with students and practicing math facts every night
- Mansfield Christian School will provide materials and training to help parents work with their students to improve academic achievement by:
 - ➤ Meeting with parents during Parent Orientation
 - Meeting individually with parents twice annually at Parent-Teacher Conferences or at other arranged times
 - Inviting parents and families to attend Family Nights twice a year
 - Sending home Reading Connection newsletters monthly
 - Providing flyers from area sources pertaining to other involvement opportunities (library's summer reading program)
- Mansfield Christian School will educate its teachers, pupil services personnel, principals and other staff in how to reach out to, communicate with, and work with parents as equal partners in the value and utility of contributions of parents and will implement and coordinate parent programs and build ties between parents and schools by:
 - Annual Title I Parent Meeting

 - > Family Nights
